I. Introduction

The Pacific ICT Ministerial Dialogue 2023 (PICTMD 2023) is scheduled to be held from 28 to 29 August 2023 at the APEC Haus in Port Moresby, Papua New Guinea. The Ministerial is hosted by the Ministry of Information and Communications and Technology, Government of Papua New Guinea. Following the Ministerial Dialogue, the Policy and Regulatory Forum for the Pacific will be held from 30 August to 2 September 2023 organized by the Asia- Pacific Telecommunity (APT) and hosted by the National Information and Communications Technology Authority, Papua New Guinea.

II. Purpose

VII. Information for entry into Papua New Guinea

Visa Requirements

- Visa on Arrival are for countries under Melanesian Spear Head Ground (MSG) (Fiji, Vanuatu, Solomon Island and New Caledonia) will receive visa on arrival.
- Rest of the other countries to apply for visa on-line.
- All delegates are to ensure their passports are valid for more than 6 months before traveling with return tickets to enter Papua New Guinea.
- It is important to check whether a transit visa is required when passing through another country before entering PNG.

VIII. Host: Papua New Guinea support to the Participating Pacific Island Nations

1. Meeting in the International Airport

- 1.1 For Ministers of participating countries (HoDs)

 Ministers who will be arriving will be greeted by both Foreign Affairs, Jackson International Airport Protocol Officers and supported by Staff of the Ministry to proceed with immigration procedures through fast-track lanes for the best possible convenience.
- 1.2 HoD will be directly escorted to VIP Lounge, while the luggage's will be arranged by our Airport Staff and supported by the Ministry.

2. Accommodation

2.1 For the HoD and Delegation

Accommodation for the duration of stay in Port Moresby for the Meeting and in Kavieng for the Social Event will be catered for by the Government of Papua New Guinea.

3. Air Travel and accommodation

At the request of a delegation, the Government of Papua New Guinea will provide a return airline ticket for 1 x HoD and 1 x Delegate (CLO) and accommodation during their stay in PNG.

All delegates are advised to arrive 30 minutes before the commencement of the Opening Ceremony.

8. INSURANCE

The host and PNG will not bear any cost of insurance, medical expenses or any other expenses for all participants. Participants are advised to make necessary arrangements for insurance and medical coverage before their travel.

9. DRESS CODE

Formal (Business Suit) dress code is required for the meetings.

10. ABOUT PAPUA NEW GUINEA

Located in South Asia, Papua New Guinea has a land area of about 462,000 square kilometres. At present, PNG's population stands at about 10 million people, with English as the main language of instruction.

Weather: Day temperature averages at 32°C (86°F) and night temperature averages at 24°C (75.2°F).

Time Zone: GMT + 10 hours.

Banks & Currency: Papua New Guinea Kina (PGK) is used. Money changing services can be found at the Port Moresby Jacksons International Airport as well as at most shopping centres and hotels. Automated teller machines (ATMs) are widely available, and accept most of the main credit cards such as Visa, MasterCard and American Express. The exchange rate as at 20 July 2023 is USD1.00 = PGK 2.60

Electricity: The electrical sockets in Papua New Guinea supplies electricity at 220-240 volts and are compatible with type G plug (see pictures below. Universal Adaptors are not provided by the organisers/venue.

X. Vital General Information

1. Banking Facilities

The standard form of currency is the Papua New Guinea Kina (PGK). Foreign Currency exchange facilities are available at Jacksons International Airport and designated hotels.

There are three major banks in Port Moresby and in Kavieng, New Ireland Province; Bank of the South Pacific, Westpac and the Kina Bank.

Standard banking hours are 9:00am-3:00pm from Monday to Friday. There are Automatic Teller Machines (ATM) available in certain locations for ease of access to funds.

Credit Cards are accepted in most major resorts/ hotels and restaurants.

It is advisable for delegates to ensure they have the Papua New Guinea (PGK) before departing for Port Moresby, especially Kavieng, New Ireland Province.

2. Health Requirements

It is important to note that while it is not a requirement to receive a COVID-19 vaccine prior to entering PNG, delegates must be aware of their individual health conditions and should not hesitate to alert a Liaison Officer should medical services are required whilst in Papua New Guinea.

There is no mandatory quarantine, regardless of your history of vaccination, type of visa, etc.

3. Communications

There arethree mobile network providers; (i) Telikom Ltd) Vodafone (iii) Digicel (PNG) Limited.

Mobile Network Operators offer high-speed mobile data for accessing Internet. You can browse the internet directly through your 3G/4G data capable mobile phones or buy a 3G data modem/dongle to attach to your laptop or use your smart phones hotspot feature.

Mobile Roaming

International mobile roaming services are available in PNG.

Internet

All mobile/telecommunications service providers offer their wireless internet services. Users can purchase prepaid cards to access these services. Cards are sold at a range from K3, K5, K10, K20, K50 and K100 and can be used to purchase internet bundles.
